
Company Overview

Incorporated on August 23, 2007, China Datang Overseas Investment Co., Ltd. (hereinafter referred to as "Datang Overseas Investment", "the company" or "we") is a wholly-owned subsidiary of China Datang Corporation Ltd. (hereinafter referred to as "China Datang", "Datang Corporation" or the Corporation), and is the main window and platform for overseas business of the Corporation. It is mainly engaged in investment, construction and operation of overseas energy projects, operation and maintenance, general engineering contracting, international trade, technical services and other related businesses.

At present, the company has 500 employees and total assets of 20.575 billion yuan, and our businesses are distributed in Southeast Asia, Central Asia, Africa, America and Europe. With 6 active projects, the installed capacity in service exceeds 1,000 MW; more than 10 key preliminary projects are being promoted, and the capacity of key pipeline projects exceeds 5,000 MW.

While expanding international business, the company has actively integrated into the local community and strongly promoted the local economic development, which has been highly evaluated and appreciated by the host country and won the " Top Ten Successful Chinese Enterprises in ASEAN Award" several times.

The millennium Silk Road spans ancient and modern times. The "Belt and Road" Initiative, based on the "Silk Road Spirit" of "peace and cooperation, openness and tolerance, mutual learning, mutual benefit and win-win", has shown the world a new concept and mode of cooperation. With the golden autumn of 2013 as the starting point, it opens a brand new chapter of the world development process. As a window enterprise of overseas business of the Corporation, the company actively participates in the construction of "Belt and Road" Initiative. By focusing on its main business and cultivating deeply, it carefully carves out "business card" projects with the spirit of "fine brush painting". The company has written an eternal footnote for "Belt and Road" Initiative by focusing on its main business and working hard. At present, the company has 11 overseas projects, with an installed capacity of over 1,000 MW in service and an annual power generation capacity of 1,473.91million kWh.

At present, the overseas projects the company invests and develops mainly includes the following:

A Myanmar Dapein I Hydropower Station Project

With a total installed capacity of 240 MW, all 4 units were put into operation in 2010. In 2020, the power plant overcame the adverse effects of the pandemic and independently completed the repair of the flood-damaged access road, successfully coped with the biggest flood since the commissioning of the plant on August 19, and achieved stable production and increased revenue, which was highly appreciated by the Ministry of Electricity of Myanmar.



230kV Transmission Line Project in Cambodia

The first overseas grid BOT project of the Corporation, this transmission line project is the highest voltage level and longest transmission mileage grid project invested by Chinese power enterprises in Cambodia in BOT mode, with a total line length of about 294km. The grid accounts for one third of Cambodia's total power transmission projects. The completion of the grid has ensured Cambodia's energy independence and security, and has been hailed by the Cambodian government as "a model of friendly cooperation between Chinese enterprises and Cambodian government".

Cambodia Stung Atay **Hydropower Project**

Located in Ou Sang commune, Levon district, Pursat province, western Cambodia, with an installed capacity of $2 \times 10 + 4 \times 25$ MW, all 6 units were put into operation in 2013, providing clean energy to Cambodia, meeting the electricity needs of 740,000 people in the central and western regions of Cambodia, and creating hundreds of jobs for the local community.

December 20, 2016, with an installed power generation capacity of 2×175 MW.

Indonesia Kendari Power Plant Project

Located on Sumatra Island, it was put into operation on Located on Sulawesi Island, it was put into operation on October 29, 2019, with an installed power generation capacity of 2×56 MW.

Located in Kalimantan, it was put into operation on November 4, 2020, with an installed capacity of 2×115 MW.

With a total investment of 540 million US dollars and two 225MW sub-critical coalfired generating units, the project is China Datang's first international tender greenfield project and the largest infrastructure project in the Aceh region in terms of investment scale. Since the construction of the project, it has provided 832 person times local job opportunities and will increase tax revenue for Indonesia by 171 million US dollars during the operation period, laying the foundation for the rapid industrialization of Indonesia.



Cases Myanmar Dapein I Hydropower Station: Exceeded the target and made a good start in the New Year

The sudden arrival of the COVID-19 pandemic has brought new challenges and opportunities for overseas enterprises. On the basis of ensuring the safety of pandemic prevention, Myanmar Dapein I Hydropower Station has been doing its best to ensure the safety and production of electricity. The Hydropower Station has been doing its best to ensure the safe and stable operation of equipment by strengthening equipment maintenance and operation dynamic management, implementing technical transformation, unit overhaul and equipment defect elimination. As of 18:59 on February 28, 2021, the annual power generation capacity of the Hydropower Station reached 100 million kWh,, an increase of 11.66 million kWh year-on-year, reaching 100 million kWh, one day earlier than the historical best value, which is a record high, and at the same time, made a good start for the New Year.



PROJECT DEVELOPMENT AND CONSTRUCTION

The company strictly implements the "20 words" development requirements of "key breakthrough, orderly advancement, rhythm control, long-term reserve and disposal", prepares development manuals for each country, researches and forms research reports on power investment in overseas countries, and steadily pushes forward overseas business to strengthen and expand. In 2020, the company focused on the key points and made precise efforts, and used multiple strategies to tackle the problems. Datang DSSP Power Indonesia project was officially delivered, becoming the first overseas acquisition project successfully delivered by the Corporation; we have made great efforts to solve the problem of shortfall in funding of Meulaboh project. All development projects have been orderly promoted and made positive progress, and overseas business has achieved milestone leapfrog development.






STEADY IMPROVEMENT IN QUALITY AND EFFICIENCY





Reinforcement of Emergency Drills
